BUSINESS OBJECTIVES

- provide training and widespread dissemination of health information for members which will create an awareness of alternative solution to health challenges
- provide in house and ambulatory support for those in need
- promote love, personal responsibility and self mastery

- initiate, develop and encourage better and more economical methods of production, processing and marketing of safer products and treatment methods
- make arrangements for the proper manufacturing, processing, and distribution of products to members with a view towards ensuring quality
- acquire, erect, control, manage or operate any organization, buildings, business or factory for the purpose of promoting quality health care
- act as an agent for its members in procuring medicines, seeds, herbs, equipment, facilities and expertise for the promotion of healthy living
- enter on behalf of its members, into arrangements or contracts with any person, Government or Non Government organizations, for the marketing or sale of any approved product(s) and service(s)
- promote the cultivation of safer organic food products and for this purpose, to organize meetings and provide field services either directly or in collaboration with other organizations promoting safer organic farming practices
- associate itself with other registered Societies for mutual benefits
- receive the funds of its members, either as payments on shares, or as prepayments for services provided
- invest in any security in which Trustees are for the time being, by law, authorized to invest
- raise funds on loans for the objects of the Society and for making the necessary credit to members
- make such investments of available funds as may from time to time be thought fit
- borrow money with or without security on all or any of the Society's properties as per the limit set at the Annual General Meeting
- levy cess on all or any approved product(s) being marketed by the Society on behalf of its members for the purpose of the development of the business of the Society
- make contact with members requiring such members to actively seek to improve their own health and

conditions by using the information and services the Society has to offer

- provide customers and members with good quality products and services at reasonable price
- develop healthy, knowledgeable, well-adjusted members through training and regular contact with a view towards developing ambassadors of healthy lifestyles
- encourage the use of pooled resources and efforts to offer cost effective solutions to health challenges
- do all other acts and things as are incidental or conducive to, or consequential upon the attainment of the aforesaid objects.

MEMBERSHIP

The membership of the Society is broad-based and has several other medical, paramedical and other supporting members. Membership of the organisation is persons/ organizations, who can make use of its services and agrees to abide by these Rules and other registered Societies that can utilize the products and services of the Society. The Foundation is based on an entrance fee of \$2,200 and a minimum of 2000 shares each at \$1.00 each for individuals and entrance fee of \$2,200 and a minimum of 20,000 shares at \$1.00 each for other cooperatives. The Society is managed by an Executive Committee (all paid up members), consisting of President, Vice President, Secretary, Treasurer and three other Directors.
